ORDER

The Conditional Affiliation for starting a new Self-financing Law College viz. Nehru Academy of Law, Lakkidi, Mangalam, Palakkad under Nehru College of Educational and Charitable Trust with 3-year LLB and 5-year BBA-LLB programmes of 60 intakes each, for the academic year 2015-16, was granted vide U.O read as 1<sup>st</sup> and Confirmation of Conditional Affiliation was granted vide U.O read as 2<sup>nd</sup>.

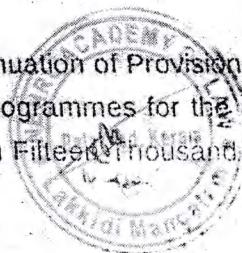
2. Provisional affiliation was granted to 5 year BCom, LLB(Hons) programme with an intake of 60 for the academic year 2021-22 implementing judgement dated 29.07.2021 in W.P.(C) No.12212/2021 from Hon'ble High Court of Kerala, vide U.O read as 3<sup>rd</sup>.

3. Continuation of Provisional Affiliation to 3 year LLB, 5 year BBA, LLB & 5 year B.Com ,LLB (Hons) programmes with an intake of 60 students each for the academic year 2022-23 was granted on conditional basis subject to the submission of approval order from Bar Council of India and renewal NOC from Government of Kerala for the year 2022-23, vide U.O read as 4<sup>th</sup>.

4.The Bar Council of India, vide paper read as 5<sup>th</sup>, has granted extension of provisional/ temporary approval for the 3-year LLB, 5-year BBA-LLB (Hons) and 5 year BCom, LLB (Hons) programmes for the academic year 2022-23.

5. The Dept. of Higher Education, Govt. of Kerala has renewed the NOC for the 3-year LLB,5-year BBA-LLB(Hons) and 5 year B Com, LLB (Hons) programmes for the academic year 2022-23 vide G.O read as 6<sup>th</sup>.

6.The Principal vide paper read as 7<sup>th</sup>, has requested for Continuation of Provisional Affiliation to 3-year LLB, 5-year BBA-LLB (Hons) and 5-year BCom-LLB (Hons) programmes for the academic year 2023-24. The college has remitted Rs.1,15,765/- (Rupees One Lakh Fifteen Thousand Seven Hundred Sixty Five only) towards the Administration and Affiliation fee .

7. The nomenclature of 5 year BBA,LLB programme is changed to 5 year BBA,LLB (Hons) with effect from the academic year 2015-16 vide U.O read as 8<sup>th</sup>.

8. Considering the above, the Vice Chancellor has accorded sanction (i) to grant Continuation of Provisional Affiliation to the following programmes as detailed below in Nehru Academy of Law, Lakkidi, Palakkad for the academic year 2023- 24 on conditional basis subject to the submission of approval order from Bar Council of India and renewal NOC from government for the academic year 2023-24 with strict directions to engage faculties with qualifications prescribed by the UGC and in compliance with the provisions of the ACT 13 of 2021 Kerala Self Financing teaching and non teaching employees(Appointment and conditions of service)

9. Orders are issued accordingly with the following terms and conditions:

- i. Affiliation granted is strictly provisional and only for the academic year 2023-24.
- ii. Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time.
- iii. In the light of the directions of the Hon'ble Supreme Court of India in WP (C) 656/1998, the institution shall take appropriate measures for the prevention of ragging in any form.
- iv. Conduct of University Examinations of any sort including that of S.D.E Examinations is compulsory and binding on all colleges affiliated to the University of Calicut.
- v. Admission to the next academic year shall be made only after obtaining prior permission from the University.
- vi. Violation of any of the above may lead to the cancellation of affiliation.
