GLIMPSE OF EVENTS



Moot court is a pedagogical exercise designed to focus law students on certain elements of bringing a case before a hypothetical appellate court. Moot court helps students to analyse legal issues; its larger purpose is to teach students the practical side of practicing law. Typically, law students

are given a detailed hypothetical fact scenario that raises one or more legal issues. Then, they conduct research, finding statutes, regulations and caselaws for supporting their position. Students then draft appellate briefs, which are formal legal papers combining a recital of the facts of the case with analysis and argument of the legal issues raised. As with the real appellate courts, moot courts generally dictate many specific requirements for a brief including the size of the paper, the width of the margins etc. Citations to legal authority must also be listed in a uniform style.

Once the brief is written, students prepare for the second phase of moot court advocacy oral argument. Oral argument demands preparation, organization, and the ability to think quickly and respond convincingly. Students learn to anticipate difficult questions about their legal position and respond intelligently and persuasively.

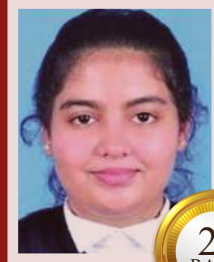
