ORDER

Conditional Affiliation for starting a new Self-financing Law College viz. Nehru Academy of Law, Lakkidi, Mangalam, Palakkad under Nehru College of Educational and Charitable Trust with 3 year LLB and 5 year BBA LLB programmes of 60 intakes each, for the academic year 2015-16, was granted vide U.O read as 1st and Confirmation of Conditional Affiliation was granted vide U.O read as 2nd.

- 2. Provisional affiliation was granted to 5 year BCom LLB(Hons) programme with an intake of 60 for the academic year 2021-22 implementing judgement dated 29.07.2021 in W.P.(C) No.12212/2021 from Hon'ble High Court of Kerala, vide U.O read as 3^{rd} .
- 3. Continuation of Provisional Affiliation to 3 year LLB, 5 year BBA LLB (Hons) & 5 year B.Com LLB (Hons) programmes with an intake of 60 each for the academic year 2024-25 was granted on conditional basis subject to the submission of approval order from Bar Council of India and renewal NOC from Government of Kerala for the year 2024-25, vide U.O.s read as 4th.
- 5. The Bar Council of India, vide paper read as 5th, has granted extension of provisional/ temporary approval for the 3 year LLB, 5 year BBA LLB (Hons) and 5 year BCom LLB (Hons) programmes for the academic year 2024-25.
- 6. The Dept. of Higher Education, Govt. of Kerala has renewed the NOC for the 3 year LLB, 5 year BBA LLB(Hons) and 5 year B Com LLB (Hons) programmes for the academic year 2024-25 vide G.O read as 6^{th} .
- 7. The Principal vide paper read as 7th, has requested for Continuation of Provisional Affiliation to 3 year LLB, 5 year BBA LLB (Hons) and 5 year BCom LLB (Hons) for the academic year 2025-26.
- 8. Considering the above, the Vice Chancellor has accorded sanction
- (i) to grant Continuation of Provisional Affiliation to the following programmes and intake, in Nehru Academy of Law, Lakkidi, Palakkad for the academic year 2025-26 on conditional basis subject to the submission of approval order from Bar Council of India and renewal NOC from the Government for the academic year 2025-26.

- (ii) for making the U.Os cited 4th as absolute, since the College has produced renewal NOC from Govt. and extension of approval from BCI for the academic year 2024-25.
- 8. Orders are issued accordingly with the following terms and conditions:
 - i. Affiliation granted is strictly provisional and only for the academic year 2025-26. The college must apply for CPA for the ensuing years by remitting the fee fixed by University from time to time, along with the extension of approval orders, if any, from the apex bodies concerned.
 - ii. The Principal shall follow the syllabi available on the University website (www.uoc.ac.in)/approved by the University for selecting courses.
 - iii. The courses in this order shall not be treated as a factor for calculating the workload for the subject or the requirement of teaching faculty, for which competent orders shall be obtained from the Government/University.
 - iv. Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and based on the directions issued by the University/Government from time to time.
 - v. In the light of the directions of the Hon'ble Supreme Court of India in WP (C) 656/1998, the institution shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent such instances of ragging, appropriate action, including withdrawal of affiliation of the college, will be initiated.
 - vi. The conduct of examinations is not permitted in colleges unless they have been granted the continuation of provisional affiliation, or their application is under process.
 - vii. The conduct of University Examinations, including S.D.E Examinations is compulsory and binding on all colleges affiliated with the University of Calicut.
- viii. The college is liable to comply with the general conditions stipulated in the renewed NOC from the Govt. of Kerala for the academic year 2025-26.
 - ix. Admission to the next academic year shall be made only after obtaining prior permission from the University.
 - X. No students shall be admitted to any course of instruction in the college in anticipation of affiliation.

Violation of any of the above may lead to the cancellation of affiliation.
